## PIER (Pollution Incident and Environmental Response)<sup>®</sup>

The PIER mobile optimized site provides AIG policyholders with a tool to contact the PIER Hotline (877-PIER-NOW) and to easily search our nationwide database for prequalified, local emergency response contractors, remediation contractors, environmental consultants, etc. who are ready to assist with every stage of an environmental incident.

The PIER mobile optimized site is formatted for viewing on a smartphone, tablet, or laptop. Once the PIER site is added to the home screen of a mobile device, a policyholder will have fast, easy access to PIER service providers and claims reporting. The ability to access PIER from a handheld device increases the opportunity at which our customers will be able to mobilize a PIER response, help to mitigate loss and prevent reputational damage in the event of a crisis.

The site also provides access to CrisisResponse<sup>®</sup> information and allows policyholders to submit a claim by completing a simple online form.


To save it to your mobile device, follow these instructions:

### For iOS devices (Safari browser):

1. Open the [www.aig.com/pier](http://www.aig.com/pier) web page in the "Safari" browser.
2. Tap the "Share" button. The button looks like a square, with an arrow coming out of it.
3. Tap on "Add to Home Screen."
4. Change the title to: "PIER AIG."
5. Tap on "Save" button.

### For Android devices (Dolphin browser):

1. Open the [www.aig.com/pier](http://www.aig.com/pier) web page in the "Dolphin" browser.
2. Click on the three vertical dots on the far right of the URL to open the drop down list.
3. Select "Add to Home Screen."
4. Change the title to: "PIER AIG."
5. Tap the "Add" button.
